

IMPORTANT NOTICE FOR WASHINGTON COUNTY WATER CUSTOMERS

New Excess Water Surcharge Rates & Water Conservation Efforts

The Washington County Water Conservancy District (WCWCD) has implemented a new Excess Water Surcharge effective January 1, 2023. This initiative is designed to encourage responsible water use and support vital conservation efforts County wide. The monthly water use threshold is based on the date the users impact fee was paid to the WCWCD.

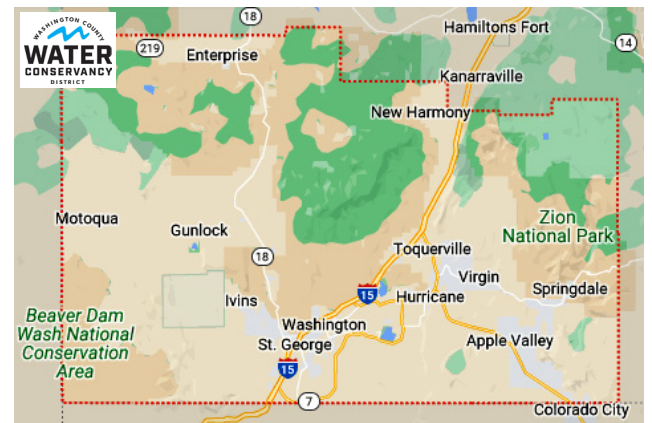

(Potable water is treated to drinking water standards. Secondary water is untreated water used for irrigation purposes.)

Non-Residential Potable Connection Thresholds

Meter Size	Excess Rate	Monthly Threshold
3/4" meter	\$1 per 1,000 gallons	36,000 gallons
1" meter	\$1 per 1,000 gallons	80,000 gallons
1.5" meter	\$1 per 1,000 gallons	260,000 gallons
2" meter	\$1 per 1,000 gallons	420,000 gallons
3" meter	\$1 per 1,000 gallons	850,000 gallons
4" meter	\$1 per 1,000 gallons	1,400,000 gallons
6" meter	\$1 per 1,000 gallons	2,600,000 gallons
8" meter	\$1 per 1,000 gallons	4,200,000 gallons



💧 Consider ways to save on water such as:

1. Replace ornamental grass with water-efficient plants and trees.
2. Checks for leaks in your landscaping and your toilets and fixtures. Fix leaks promptly.
3. Use high efficiency WaterSense™ appliances and fixtures.
4. Review your city utility bill to monitor your water consumption. This helps understand your usage patterns, control costs, and detect leaks.
5. Teach everyone in your home about the importance of water conservation & early detection of leaks.
